THE BOARD OF DIRECTORS

The Board of Directors of Eastwest Healthcare, Inc. ("Eastwest") consists of nine (9) members of whom two (2) of them are independent. The following is the profile of each of the Directors:

Non-Independent Directors

MS. RUSTIE C. PORCIUNCULA (Chairman / Director). Behind the macro management of Eastwest, is Chairwoman and Chief Executive Officer, Rustie Angeles Cuenca Porciuncula . A woman of vast experiences in different aspect of corporate settings. She is one of the Directors, and Chairwoman of the PAHMOC Mediation Committee, and member of ASIA CEO and Malaysian Chamber of Commerce.

She took over the reigns when her husband, Jaime L. Porciuncula, the Founder, Chairman of the Board and Managing Director of EastWest Healthcare, Inc., passed last May 9, 2020, due to COVID19 virus. She was exposed to her husband, but was not infected by the said virus. As a law abiding citizen, she isolated herself for 14 days as required, even if the result of the test is negative.

She was born in Batangas City on August 2, 1953.

She holds a degree of Bachelor of Science in Business Administration, major in Accounting. As a student, she was an active member of the Batangas Youth Movement and Junior Philippine Institute of Accountants in Golden Gate Colleges where she completed her college education.

She started on humble beginnings as a working student and earned her college degree in 1974. To support her college studies at the same time help augment the income of her parents who are employed in government offices, she worked as an Unskilled Laborer at the Provincial Governments assigned to function as Secretary of the Purchasing Manager, and in later years, was transferred as a typist, at the Provincial Board under Congressman Medalla.

After graduation she went to Makati for new career challenges. In 1974 she worked as an Accounting Clerk /Bookkeeper at RECB Consultancy Company. In 1975, she transferred to Executive Search, holding the same position. During her two years stay at the consultancy companies, she was deployed to a multinational company, AFIA (American Foreign Insurance Association) Worldwide Insurance as Accounts Receivable Reconcilation Assistant..

In 1976, she was accepted as an Accounting Assistant to the Chief Accountant of conglomerate Construction Development Corporation of the Philippines.

However, she when verbally advised the Controller and Assistant Controller of about her resignation and new job, she was counter offered with permanent employment status as Accounting Clerk Bookkeeper of AFIA World Wide Insurance with Firemans' Fund Insurance Company as her employer.

A year after, in 1977, she was promoted one level higher, as the Accountant of the General Agency and Brokers section of the Accounting Department. In 1981, she was hand picked to handle a newly created section at the EDP (Electronic Data Processing) Department as Head of Methods and Procedures for IBM 4330 Mainframe Platform.

In 1985, she was chosen to be a member of the International Model Office Team of CIGNA Philadelphia International Systems given the position of Methods and Procedures Analyst. She was assigned to handle the research and documentation of current data flow, sytems flow and work processes of CIGNA Philippines, Monarch Philippines, CIGNA branches in GUAM, Saipan and Micronesia, with the objective of re-engineering and implementing the Meridian System, company worldwide project.

In 1987, she was promoted as Operations Control Manager of Cigna Systems Philippines whose main function is to provide systems support to Asian Branch Offices of Cigna in Korea, Thailand, Indonesia, Guam, and Saipan, Micronesia and affiliate company Monarch Insurance Company and CIGNA Philippines.

In 1991, she became the Manager of CIGNA Philippines Information System Department. In 1992 she left CIGNA. Knowing the Meridian System by heart, she accepted the consultancy job at Monarch Insurance Company, and worked with the Chief Accountant.

In 1995, she worked as systems consultant at Blue Cross Healthcare Company and Blue Cross Insurance Company. She left Blue Cross in 1996. In 1995 up to 1998, she joined Golden Neolife Diamite International as Independent distributor. During those years, she was also involved in selling pre-need Memorial Services of Paz Life Plan under Corporate Care group, and Personal Accident Insurance Coverage of a non life insurance company.

In 1997, she established Kwentong Barbero Barbershop in Pilar Village, Las Pinas City. Within the same year, opened another branch in BF Resort Village, Las Pinas. A year after, she opened another branch inside Pilar Village, and another one in Moonwalk Village, both in Las Pinas City. She ventured with a partner and opened Kwentong Butsikoy Barbershop in Imus Cavite inside MAKRO grounds.

In 2002, she operated a canteen inside STI College in Las Pinas. In 2003 she organized a group of newly graduates from STI Las Piñas, conceptualized and developed an end to end system for, Cox Trucking Corporation. In 2004 and subsequent years she closed three of her Kuwentong Barbero branches, Kuwentong Butsikoy in Imus Cavite and her canteen at STI Las Pinas.

In 2004, she joined One Pacific Insurance Brokers as a stockholder and worked as Systems Consultant.

In 2006 she joined EastWest Healthcare as a stockholder and worked as Provider Relations Officer, for the project of getting accreditation from Medical Providers, i.e. Hospitals, Diagnostic Clinics, Dental Clinics, Medical Specialist, and Medical coordination.

In 2008, she was promoted as Vice President of Resources Facilities and Management Division. This division functions as the backdoor services for the Sales and Marketing Department of the company.
